**District Grounds Administrator Report:** In February, we had 6 burials. 5 ashes and 1 full. Year to date for 2022 we have 11 burials. 2021 was 8 and 2020 was 5. We have almost equaled the past 2 years combined. Prepping or cleaning up burial sites is taking up most of the time. The Deadwood crew was supposed to be working on cleanup for 10 days. Due to a Covid outbreak, we had a half crew for 5 days. The small part they did looks very nice. The new Niche in Evergreen is having an issue with the glue not holding the plaques due to cold temperatures. North Country Memorials can do etchings for the new niche and the columbarium in St. Joseph's. The original columbarium in Evergreen will only use plaques.

**District Office Administrator Report:** Rita Fiock requested permission from the board toput her great, great grandmother's name with her great, great grandfather's on his headstone as she has no marker. Trustee Terwilliger made a motion to allow the addition. Trustee Bacigalupi seconded the motion. Motion carried.
